UNIVERSITI TEKNOLOGI MALAYSIA RECEIVES RM 1 MILLION FROM JOHOR PORT BERHAD

SKUDAI, 5 December 2016 – Johor Port Berhad (Johor Port), a Member of MMC Group handed a contribution of RM 1 million to Universiti Teknologi Malaysia (UTM). Dato' Sri Che Khalib Bin Mohamad Noh, Chairman of Johor Port Berhad handed the contribution to Prof. Datuk Ir. Dr. Wahid Bin Omar, Vice Chancellor of UTM at a ceremony today in Johor today.

On March 2013, Johor Port signed a Memorandum of Understanding (MOU) with UTM for a RM5 million contribution to UTM's Endowment Fund. Through this MOU, UTM will receive a contribution of RM1 million every year to fund its Endowment Scholarship and other endowment purposes. To date, UTM has received RM 3 million from JPB.

The main objective of the endowment contribution is to offer scholarship for UTM's outstanding first year degree students. In addition to that, the endowment will also be utilised for the sponsorship of Professorship Chair, publication of scientific materials and implementation of high impact programmes.

Also present at the event were Prof. Dr. Azlan bin Ab. Rahman, Deputy Vice-Chancellor (Development) UTM and Encik Shahrull Allam Shah bin Abdul Halim, Chief Executive Officer of Johor Port Berhad. Dato' Sri Che Khalib Bin Mohamad Noh also handed the Endowment Scholarship Certificate to the first year undergraduate student representatives.

During his speech, YBhg. Prof. Datuk Ir. Dr. Wahid bin Omar shared that the UTM Marine Technology Centre will be named as Johor Port Marine Technology Centre as a tribute to JPB for its contribution to the university.



Since its establishment in 2009, the UTM Endowment Fund has successfully collected RM81 million including JPB's contribution which benefited 600 students with a scholarship. The Endowment Fund aims to elevate UTM as a beacon of knowledge to enhance the academic and intellectual ecosystem of the university and to promote the act of giving for scholarly deeds.
