JOHOR PORT BERHAD CONTINUES OPERATING AS USUAL DURING MOVEMENT CONTROL ORDER

Following the announcement made by the Most Honourable Prime Minister Tan Sri Muhyiddin Yassin on the 16th March 2020 at 10.00 pm on the Movement Control Order due to the evolving **COVID-19** situation in Malaysia, we would like to update you on our operational arrangement.

It is business as usual at Johor Port, Pasir Gudang during this Movement Control Order. The Terminals in Johor Port will continue to be **operating** at its optimal productivity, with trucking and Depot activities remaining unaffected.

This is in line with the announcement by the Most Honourable Prime Minister whereby essential services will continue to operate during the two-week period starting from 18 – 31 March 2020 : water, electricity, telecommunications, postal, transportation, irrigation, oil and gas, fuel, lubricants, broadcast, financial, banking, health, pharmacies, fire and rescue services, prison services, **ports**, airports, security, defence, cleaning, sundry goods and food supply.

Please be assured that you can continue contacting our offices via your usual channels for your business needs.

We will however impose certain Safety Precautionary Measures as a means of containing the spread of COVID-19 i.e.

1. Mandatory temperature checks on all staffs, tenants, contractors and visitors entering the Port premises; and
2. Restriction of all visitors from entering the Port except on urgent matters deemed critical for the Port operations.

While we acknowledge that the above measures may pose certain inconveniences and longer waiting time for Port users entering the Port, Johor Port Berhad remains fully committed to comply with any regulatory requirements and policies aimed at curbing the spread of the COVID-19.

We will continue to keep you informed of any changes to the current situation and will extend all necessary assistance for your business.
