EXEMPTION FOR IMPORT/EXPORT LADEN CONTAINERS DURING THE 2023 CHINESE NEW YEAR FESTIVE SEASON

Reference is made to the above subject matter.

As a continuous effort to assist our customers in meeting the Government Regulation on the road restriction for heavy vehicles carrying non-essential goods during Chinese New Year Festival (22nd January 2023 & 23rd January 2023) as well as limited capacity facing by the hauliers during the long holidays, we are pleased to announce our assistance to our valued customers as follows: -

i) Import Laden Containers.

Additional of two (2) days free storage will be enjoyed for containers discharged from vessels into the terminal from 16th January 2023 @ 0001 hours to 23th January 2023 @ 2359 hours (refer Table 1.0).

ii) Export Laden Containers.

Additional of two (2) days opening time will be enjoyed for vessel's ETA from 22nd January 2023 @0001 hours to 28th January 2023 @ 2359 hours (refer Table 1.0).

Kindly be informed that the extension of the free storage period as per above applies <u>only</u> to the calculation of container storage charges.

Please also take note that containers containing dangerous/ hazardous goods (JPA Cargo Group 1 & 2) and instructed by JPB's Port Safety Department or the Governing Authority to be delivered/ loaded direct shall not be included in the above privileges. Customers are urged to make effort to clear import containers from Johor Port's container yard within the given free storage period in order to avoid any potential of yard congestion and additional cost.

We would like to take this opportunity to wish all our customers a 'Happy and Prosperous Chinese New Year'.
