This Anti-Bribery and Anti-Corruption Policy Statement is complementary to and shall be read together with the Malaysian Anti-Corruption Commission Act 2009 (“MACC Act 2009”) and the Malaysian Anti-Corruption Commission (Amendment) Act 2018 (“MACC Amendment Act 2018”), JPB Anti-Bribery and Anti-Corruption Policy & Framework, JPB Whistleblower Policy and other applicable policies and procedures.

JPB Group strives to continuously improve the implementation of its Anti-Bribery Management System as a systematic framework to prevent, detect and respond to bribery and corruption risks.

Any person who commits an act of bribery, knowingly engages in or fails to report the giving, offering or solicitation of bribery commits an offence under the MACC Act 2009 and the MACC Amendment Act 2018. Upon conviction, such person shall be liable to a fine, imprisonment, or both as prescribed under the respective Acts.

JPB encourages the use of the Company’s established whistleblowing channel: jpbwbreport@mmc.com.my to raise concerns in relation to any real or suspected corruption, bribery or unethical conduct. All reports made in good faith will be treated with strict confidentiality and without fear of retaliation, in accordance with the JPB Whistleblowing Policy.
